SOP of Promotion and Fixation Subcommittee

Following steps are followed by the subcommittee, from receiving promotion application (under CAS) from the incumbent to forwarding of the completely processed file to the DPI for fixation in the higher scale applied for :

1. The incumbent has to submit the application of promotion to the Principal through the subcommittee. The subcommittee places the applications to the Principal for further action in the forthcoming Governing Body meeting. The subcommittee also asks the incumbent to furnish the complete CAS file without delay for further processing.
2. After the incumbent submits the complete file to the subcommittee, a meeting of the subcommittee is convened for distribution of the file to its members for scrutiny. During the process of scrutiny, the incumbent may be called for any consultation related to the data presented in the file.
3. In the meantime the subcommittee seeks the names of the experts from the Government as well as from the affiliating University.
4. After checking the CAS file by the subcommittee members and complying with the necessary suggestions by the incumbent, the file is forwarded to the IQAC coordinator and Principal for their signatures required in the file.
5. After receiving the names of the experts from the Government as well as the University, the Principal arranges for a meeting date in consultation with the experts for the selection/screening of the incumbent for the promotion applied for.
6. After the selection/screening meeting, Principal is requested to arrange for a Governing Body meeting for further processing of the CAS file after which the completely processed file is forwarded to the DPI as per rule for the fixation of the incumbent in the higher scale applied for.

The meeting was held in Google platform in online mode at 8pm on the 9th of November, 2021.

Joint Convener, Tushar Kanti Saha, shared the meeting link and presided over the meeting.

Following are the meeting resolutions :

1. TKS conveyed that a dedicated google account has been created, by Barnali madam, for the subcommittee with the sole purpose of communications related to promotion of the faculty members and using the associated Google drive for preserving all data of the committee and other faculty members related to promotion.

2. 6 teachers (Nitai Gayen, Netai Roy, Bibhas Ch. Mondal, Bilquis Begum, Dhiman Karmaker and Gautam Datta) submitted their documents related to their promotion to the previous subcommittee which was scrutinized by members of the previous subcommittee and TCS and requisition has been sent to both DPI and CU for sending the names of Govt. experts and University subject experts for further action. Therefore, further checking is not needed for those documents by this committee.

3. TKS also informed that 3 SACT teachers (Subarna Sen, Arghya Mondal, Sankhanil Dey) applied for promotion to next category, but the processing could not be initiated as a letter to DPI office is already submitted regarding clarification of Ph.D. equivalent criteria for one of the SACT (Sankhaneel). BRB madam also reported that the IC of C.U. was consulted about the issue, who clarified that the University has no role to play regarding the promotion of SACTs. DPI office is to take all decisions related to their promotion. TKS sir proposed to appraise the matter to the Principal for further communication to DPI office regarding this.
It was also proposed to arrange for a guideline for SACT-promotion.

4. BRB madam reported about the present status of the two incomplete promotion processes, one of Raju Mondal and the other of Subhrajit Banerjee. She conveyed that, Raju Mondal has already prepared his docs for CAS as per suggestions of the Govt. expert. Suvrojit Banerjee of Physiology Dept. is also ready with his CAS file and is waiting for proper moment to resubmit it to the University nominee.

5. It is resolved that before sending requisition for expert names from DPI and University, a preliminary note of no objection on the CAS file of the concerned Promotion seeker for further processing will be required from the corresponding scrutineer member of the subcommittee.

6. NG sir reported that earlier some promotion seekers added their names in the requisition for expert names for CAS without submission of their CAS files to the subcommittee for scrutiny.

It was resolved that this should not be allowed to recur in future.

7. NG, NR and others proposed for a workshop of teachers to be arranged for briefing the faculty members about promotion related issues and queries.

The subcommittee resolved to arrange such a workshop in the near future.

8. NG proposed that teachers, who will require promotion in future, should be included in different committees for their benefit. He also proposed that before submitting an application for promotion to principal, the concerned faculty members should show their preliminary CAS files to committee-members for justification of their preparedness.
